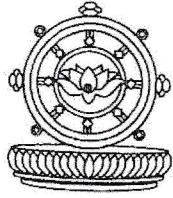
Dear Gyalpo Rinpoche,

We are very sorry about the passing away of Lama Gyalsten. It is a great loss to both Karma Samtenling Monastery and Nunnery ! Lama Gyalsten was also the most important guidance and communication media between our Foundation and Karma Samtenling Nunnery.

In our Foundation, the one Director who was responsible to raise money for Karma Samtenling Nunnery and communicate with Lama Gyalsten is Mrs. Wong Chan Mei Ki. Her business was in China where she had been stuck in for 18 months during the Covid 19 pandemic . She was therefore unable to return to Hong Kong to carry out her job in Nunnery fund raising , but was only able to maintain this task in China during this period. Mrs. Wong worked very hard and was very devoted to her works in our Foundation. However, due to retirement age, and she has to take care of her elderly husband, she resigned from Lama Gyalsten (Nunnery) and our Foundation since February 2021. Therefore, our Foundation has officially stopped raising money for Nunnery since February 2021. The donations and the balance for Nunnery we have already given to your monastery 3 times this year.

We would like to reconfirm the followings with your monastery:

Our Foundation offered a piece of land of area about 80000 sq.ft. in Katmandu to your monastery in 2006, ie., 15 years ago, to build Nunnery. This land had been left vacant because of past water problem (The present Nunnery is located at another piece of land which was also offered by our Foundation). In March 2021, Lama Gyalsten informed that Rinpoche agreed to sell this piece of land, and the money obtained will be used for completion of the Nunnery project, and the remaining amount will be put in bank for future food of Nunnery, governed by 3 persons. The above is in accordance with our request. According to Lama

Gyalsten, the sale price of land at peak was about 10 million Hong Kong Dollars. However, due to the increasing severity of Covid 19 in India and Nepal, the sale of land became difficult, and the price of land may also drop.

For formality and to protect the interests of all our Foundation sponsors, our Foundation sincerely requests that even after Lama Gyalsten passing away, your monastery will make every effort :

- 1, to sell the piece of land at reasonable good price.
- 2, to continue and complete the Nunnery project.
- 3, the money obtained from the sale of land will be governed strictly to use for completion of Nunnery project and for future food and expenses of Nunnery, or even for Monastery if it is necessary.
- 4, We strongly object any misuse or personal use of the money obtained from the sale of land as it is Dharma !
- 5, Our Foundation has also offered another 2 pieces of land at the backyard of Nunnery, which are intended for Nunnery retreat centers in future. We would like to request Monastery to govern these 2 pieces of land not to be sold for personal benefits or usage.

In future, if any occasionally donation for Nunnery we receive, we will give to you at the end of our financial year.

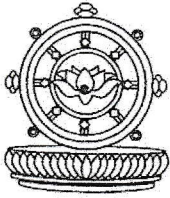

對於高晨喇嘛的圓寂，我們基金會深感悲痛！高晨喇嘛的離別是噶瑪禪揚寺及噶瑪禪揚女尼寺的極大損失，高晨喇嘛也是我們基金會籌募女尼寺的最大指導及溝通橋樑！

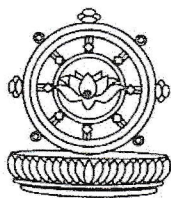
我們基金會一向由董事黃太(黃陳美琪)負責籌募禪揚女尼寺建設及生活費的工作及與貴寺總管高晨喇嘛聯絡，惟她個人生意在國內，新冠疫情期間曾滯留國內一年半之久，期間只能保持在國內籌募，無法回港主理禪揚女尼寺香港的籌募工作。黃太一直很盡心盡力為本會的工作，惟基於已屆退休年齡及要照顧年長的丈夫，已於2021年2月向高晨喇嘛(女尼寺)及本會申請離職，故本會於本年2月起已停止女尼寺的籌款，而贊助款及餘額本會今年已分3次交貴寺。

現本基金會與貴寺再確實如下:

本會於15年前2006年供養給貴寺一幅8萬平方呎的吉地以建女尼寺，但早期因食水問題一直擱置，(現時女尼寺是建於另一塊由本會供養的地)。本年3月，高晨喇嘛通知本會，經開會後，嘉波寧波車同意賣出這地，所得賣地款將會用作完成女尼寺建設，餘款放入銀行帳戶經3人監管，用於日後女尼寺的生活費，這是依照本會的要求。據高晨喇嘛稱，最高售地價時達港幣一千萬元。但可惜印度及尼泊爾疫情嚴重惡化，賣地變得困難，及地價也隨着下跌。

為正規程序及保障所有佛慈功德主的利益，本會再誠意懇請希望貴寺能盡力:

1. 將上述吉地以適當高價售出。
2. 繼續建設及完成女尼寺

- 4, 依佛法而言, 本會強烈反對賣地款濫用或用作私人用途。
- 5, 本會亦曾供養2塊地於女尼寺後方用作日後建設女尼閉關用途, 本會希望貴寺能嚴格監管這兩塊地, 不會用作私售得益或其他私人用途。

若日後仍間中收到女尼寺贊助, 本會將集中於年度結算前交貴寺。
